### **Min 56 / Sept / 06 Transportation and Highways**

1. Bank Buildings. Concern was expressed over issues raised in the refusal of Planning consent for parking for the Cawdor Hotel. It was proposed by Cllr Roy Davies and seconded by Cllr Colin Jenkins that a site meeting be arranged between the Trunk road Agency, Trevor Sage of CCC, The Planning Officer, The Police, CC Ieuan Jones, AM Rhodri Glyn Thomas and representatives of the Cawdor Hotel. This would be held on either the 12<sup>th</sup> or 13<sup>th</sup> of October.
2. Notice of Road Closure on September 18<sup>th</sup>. Despite our previously sent response to the Highways department of CCC, members were very unhappy with the arrangements made. It was agreed that Cllr Roy Davies would send a press release for local residents to be aware of the Council's objections.

### **Min 57 / Sept / 06 Footpaths report**

1. Mr Des Davies gave a detailed account of the state of the footpaths. The Footpath below the White Hart Inn and the Nant y rhibo footpath had been included in the paths to be maintained in future. Caroline Ferguson of CCC was prepared for her team to clear the paths prior to the Council adopting them.
2. Carmarthenshire Local Access Forum. Details of a meeting held in August. The Council were not informed until two days after the event.

### **Min 58 / Sept / 06 Correspondence**

1. CCC – Re works to be carried out to fell trees at Dinefwr Park. Noted.
2. Community Association. Copies of letters sent to CCC asking for a water bowser to be placed in the car park, as well as a supply of water for watering hanging baskets.
3. Community Association – copy of letter sent to CCC complaining about Car parking charges
4. Mrs Needham- requesting permission to place low planters along the wall at the side of her shop. Agreed that the Technical Officer would liaise with her.
5. Mr John Smallwood requesting details of burial regulations – refer to CCC
