The Mayor Cllr Edward Thomas gave a report of the progress made. The programme was at the printers. 1200 copies had been ordered at an estimated cost of £ 1480 . Councillors had agreed to deliver the programmes by hand to each household. The Mayor encouraged all Councillors to dress in Edwardian costume for the parade. The next meeting would be held on June $3^{\rm rd}$.

Cllr Roy Davies stated that the Council stall at the event would focus on Llandeilo Past and Llandeilo present. He asked for assistance in manning the stall during the afternoon.

Mr Davies stated that the new benches had been put in position. The paths in Penlan Park were being tarmacadamed.. He hoped that a meeting of the stewards, for the Penlan Park celebrations, could be arranged as soon as possible.

Mr Hugh Gwynne had completed the first grass cut of the year. He had reported that there was severe dog fouling between the transport area and the King's bridge. The Vicar had agreed to the placing of 2 new benches inside the cemetery.

As a result of a discussion it was agreed to ask the Street scene department of CCC to replace the damaged street signs around the Town, as well as adding to the number of litter bins along the Crescent.

The Mayor presented a report of the events attended during the month on behalf of the Council.

Min 55 / May / The World Sheepdog Trials Sub Group

The Clerk presented a report of the sub group meeting. Cllr Hugh Towns proposed that the Council book the Welsh Regiment's Fifes and Drums together with the Regimental Mascot, Shenkin the goat for the parade of competitors on Wednesday, September 10^{th} at a cost of £1000 plus travelling expenses . This was seconded by the Mayor. All were in favour. Cllr Colin Jenkins had contacted the two Primary schools to ask them to produce the nations flags for the procession. The Council had been allocated a stand in the Marquee provided at the site at Newton House. The Civic Hall was to be booked for the reception . Tregib school were to be asked to provide waiters/waitresses to serve the buffet. A local choir and Dawnswyr Penrhyd would provide entertainment during the reception.
