**Min 255/ Feb / 08 Planning Applications for Decisions**

E/18173 To remove conditions 5&6 from the permission granted on application E/13994 (12.12.06). This is to separate parking from the shop and flat at 11, Bank Buildings and provide autonomy for the dwelling for the purpose of sale

**Comment : The Clerk was asked to request written copies of the conditions 5&6 mentioned in the application, as well as an extension to consider these at the next meeting. CCC Planning were asked to bear in mind the complex nature of the redevelopment of the whole area of Bank Buildings in their consideration of the application.**

**Min 258 / Feb / 08 Transportation and Highways**

1. WAG – notice of changes in waiting restrictions along Rhosmaen Street and Bridge Street. Members did not have any objections to the restrictions in Rhosmaen Street. The Clerk was asked to write stating the Council's opposition to the changes proposed in Bridge Street. Councillors wished to express their opinion that the changes would make it more dangerous for residents, as it would mean that they would have to cross the highway to access their vehicles. Copies of the letter was to be forwarded to Adam Price MP, Rhodri Glyn Thomas AM the Police and local newspapers. The Council were disappointed that previous objections sent to the WAG had seemingly been disregarded.
2. The National Grid.- Letter informing that the gas pipeline had been completed. Noted.

**Min 260 / Feb / 08 Licensing – Re. 44, Rhosmaen Street**

The result of the Appeal into this application was given with permission being granted. The hours of opening were to be from 8am until 12 midnight from Sunday to Thursday, and 8-1am on Friday and Saturday evening . There would be an additional 30minutes drinking up time.

**Min 261 / Feb /08 Footpaths Report.**

A notice to divert the footpath ( 69/1) along the Crug Manor footpath was discussed. The Clerk to respond stating that the notice was sent out after the work had been completed. There were no signs to direct walkers.

The Clerk was asked to contact CCC regarding the request by a resident to have a hedge bordering his property to be maintained.
