Min 300/ Mar/ 15 Other Financial Matters

1. Three Year Budget Forecast

It was agreed not to make any changes at this time.

2. Purchase of New Office Computer.

The Finance Officer reported that the new office laptop had been purchased and installed in the office with full range of software and anti virus protection . The old PC had been decommissioned. All data from the PC had been transferred onto the new machine. Mr Plummer stressed that this was for the use of all staff and Councillors.

3. The Council laptop provided for the Clerk's home use.

Following a report from Andrew (Easy PC), the Finance Officer recommended that the current

laptop be replaced with a similar machine to the one installed in the Office. It was proposed by Cllr Eifion Davies, seconded that that this laptop be replaced. All were in favour. This machine would remain as the Council's property.

4. The Finance Officer circulated the current Risk Assessment Document and asked Members to consider by the next meeting if there was need to make any alterations.
 5. The Finance Officer circulated of the Fixed Assets Register for Members to review and report back by the next meeting any changes that was required.
 6. The Clerk had received correspondence for Mr Geoffrey Williams. Mr Williams wished to thank the Council for its donation of £ 250 towards the proposed Towy Festival of Walks. Mr Williams stated that the Festival had been deferred until next year due lack of time to organise the event. Mr Williams had therefore returned the cheque.
