Min 201 / Nov / 15 Other Financial Matters

1. Remuneration Board Report from the Welsh Assembly Government

The Finance Officer presented a report to the Committee. The aim of this report was to provide more consistency between County Councillors and Town And Community Councillors as far as available expenses were concerned. He stated that the Town council adhere to three of the

six determinations mentioned . These were :-

- i) The right to claim travelling expenses for undertaking Council business
- ii) A Civic allowance for the Mayor
- iii) Expenses for the Officers in carrying out their duties.

The committee thanked Mr Plummer for the report.

2. The Three Year Budget Forecast.

Mr Plummer produced forecasts for the remainder of the present financial year as well as forecasts for the next two years based on different options in rises in precept demands.

3. Additional payment to the Technical Officer.

The three Officers were asked to leave the room whilst this confidential matter was discussed. It had been agreed that the Technical Officer would be paid an additional one hour payment per week in respect of the extra working hours worked for the three community events organised by the Council. This was passed under Minute 57 / May/15. This sum has been paid from June 1st 2015.

However it was proposed by Cllr Edward Thomas that Mr Davies be paid this additional payment from April 1st, as the start of the financial year. Cllr Geraint Price seconded the proposal . All were in favour. The Finance Officer would be informed to arrange for any back pay between April 1st and June 1st to be added to Mr Davies' salary.
