#### **Police Matters.**

PCSO Louise Lewis reported that there had been several incidences of graffiti in Penlan Park and in Parc Le Conquet. The Notice board in the alley near the car park has been damaged. A community order is to be served on a resident from 89, Rhosmaen Street. Reports had been received that vehicles at the ambulance Station had been damaged. There had been a break-in at the Llandyfeisiant church and damaged caused.

Officers called to party in a house in Rhosmaen Street due to excessive noise witnessed drugs being used. The landlord will evict some tenants.

Chairs have also been removed from outside Café Braz.
