Min 70 / June / 16. Declarations of Interest.

Cllr Colin Jenkins declared an interest in the Planning Appeal made by CK's supermarket, and signed the Book of declarations of interest.

Min71 / June /16. Election of Chairperson for the Planning Committee for 2016/17.

Cllr Julia Jones was proposed by Cllr Eifion Davies, seconded by Cllr Gordon Kilby. All were in favour.

Min 72 / June /16. Election of Vice Chairperson for the Planning Committee for 2016/17

Cllr Geraint Price was proposed by Cllr Eifion Davies, seconded by Cllr Richard Wallace. All were in favour.

Min 73 / June / 16 Planning Application for Decisions

E/ 33879 Change of use of Unit 1 from light industrial to B1 to D2, Assembly and Leisure, in the form of a Gymnasium/fitness and Health Centre at Unit 1, Pencrug, Carmarthen Road.
Comment : No objections.

E/ 33889 Change of use of part of building to mixed use (comprising of beauty salon on ground floor, therapies/ massage treatment rooms on first floor and yoga studio on second floor) at 22, Carmarthen Street.
Comment : No objections. However concern was expressed that this is a listed building yet no Listed building application has been circulated to the Council.
Also in this application and for application E/ 33879 indication was made that no work had been started prior to the planning decision process when it is obvious that work had indeed been carried out prior to this.

Min 75 / June / 16 Other Planning Matters

1. Planning Appeal lodged against the decision of CCC to refuse the following planning development :
CK's Car Park opposite 77, Rhosmaen Street for priced products on ground anchored placard boards, 8 in type hoarding, 2 in type with priced product offer.
The Clerk was requested to re-submit its original objections to the development. Council believes that these boards are a distraction to drivers on a busy junction between the A483 and the New Road to Crescent Road crossing
The boards are not in keeping with a conservation area. The price information has also not been updated on a regular basis.
