# 6363/Feb/05 Planning Applications for Consideration:

### 6370/Feb/05 Conservation Area

Mr Ian Thomas, Conservation Officer from Carmarthenshire County Council attended discuss Conservation Area Planning in general. There are 27 conservation areas in Carmarthenshire. He would provide a map of the Llandeilo conservation area for Councillors, and a list of listed buildings. Mr Thomas will also check to see if there is an easy guide for Councillors.

Trees in a conservation area are subject to preservation orders. Trees with a bore less than 7" or 8" may usually be removed. There are regulations governing the removal of any hedgerow which is a boundary. Farmers may replace hedgerows and trees which form a boundary. Rosie Carmichael will investigate and possibly prosecute if necessary.

There are different restrictions for householders and commercial premises in conservation areas. Householders could use UVPC windows. Satellite dishes were not acceptable. If a property has enjoyed light to a room for 20 years and there is a proposal for a planning scheme which would block it off, there is an entitlement to prescriptive light and one can appeal.

Councillors asked if Llandeilo would benefit from a Town Heritage scheme such as Llangadog and Llandovery have recently benefited from. Mr Thomas explained that Llandeilo had previously had lots of money spent on the Bridge Street development in 90's. Llangadog and Llandovery were identified by CADW as prime candidates due to the level of deprivation and deterioration of the fabric of the buildings.

Future schemes to co-ordinate the street furniture, a design scheme for planning purposes, etc may be incorporated into the County Council's planning process.
