  - All Councillors were invited to complete the questionnaire to submit their own views.
- 3. Exercise Apparatus in Parc Le Conquet.
  It had been reported to the Clerk that the Exercise Apparatus in Par Le Conquet was broken. It was proposed by Cllr Colin Jenkins that he Clerk contact HAGS for advice. Cllr Dawn Wallace seconded. All were in favour.
- 4. Llandeilo Tennis Club.
  - i) The Clerk reported that the courts had been sprayed by Toppers in order that the Ladies team could fulfil their fixtures. Noted.
  - ii) Terry Davies would drain the water from the Tennis pavilion over the winter to avoid burst pipes
    - It was proposed by Cllr Robert Jones, seconded by Cllr Christoph Fischer that Tennis Club issues by discussed at the next Parks Management Group Meeting. All were in favour.
- 5. Town Christmas lights.
  - Most of these had been erected. However, the owner of the White Hart had requested that a motif be erected on her premises. The contractor would be contacted to see if there were any motifs available. Proposed by Cllr Owen James, seconded by Cllr Christoph Fischer.
  - Cllr Colin Jenkins had offered to monitor the town's lights over the season. The Clerk would provide him with notices to remind businesses not to switch off the motifs as there would be accost implication to reset the time switches. Noted.
